### **Municipal MS4 Stormwater Management Programs:**

NP&V has developed Stormwater Management Programs under the NYSDEC SPDES Phase II Program for several Villages on the north and south shores of Long Island, as well as the subsequent NYSDEC Annual Reports. The MS4 Stormwater Management Programs include established goals and timelines for ease of implementation of the six minimum measures required under the program.

NP&V identified recommended best management practices (BMPs) and good housekeeping practices for municipal operations, prepared fact sheets and public education and outreach documents, conducted code reviews and assisted in amendments of local laws/building permit applications to assist with municipal implementation and enforcement of the Stormwater Phase II program.



### **NYSDEC General Permit for Stormwater Discharges from Construction**

**Activities:** NP&V has prepared 80+ Stormwater Pollution Prevention Plans (SWPPP) and associated permit filings. Each SWPPP includes a detailed Erosion and Sediment Control Plans, an assessment of stormwater runoff characteristics, construction sequencing, maintenance procedures for erosion and sediment controls, pollution prevention measures during construction activities, and a post-construction hydrologic and hydraulic analysis for all structural components of the stormwater system.
